Report on changes in Policy or Practice that were implemented

None to report.

Problems encountered/ concerns

The annual Boy's Golf Sectional Qualifier is and has always been the 3rd Monday in May, every year since the AP Exam Schedule changed to end one week later. Although there are many times we cannot avoid conflicts with Rain Dates and other Sectional events, we SHOULD definitely avoid conflicts with (2 or more) sports having Sectionals on the same date. Boy's Golf initially had a conflict with Boy's Tennis this year but in the end it was resolved – not an issue. If there is a way we can prevent having to deal with these conflict(s) in the future (not the week before the event), I'd highly recommend it, as it is the right thing to do for our student athletes. These conflicts are 100% avoidable with prior planning and coordination in my opinion.

The Boy's Golf and Boy's Tennis STATE Championships conflict and will continue to conflict in 2016. I'm concerned that if a boy that qualifies for both like this year, it places unnecessary pressure on the coach, player, parents, AD, chairmen, and Exec. Dir. to allow the player to participate in both when that may not be what's best for the player or his State Team (golf).

Contrary to what some may believe, there is a HUGE team element in Boy's Golf all the way from the league level to the State Championship level. A NYSPHSAA State Champion Golf Team has been crowned since 1973. To have a player play tournament tennis before traveling from Flushing, NY to Ithaca, NY to participate in both events basically guarantees athlete exhaustion before Boy's Golf States even begins – it's not fair to the player, his State Golf Team, or the alternate who could fully participate. Ideally we would never want to place an athlete in this position, which is why I'd recommend not having conflicting State Championship dates in the first place.

Section VI arrives in Ithaca for B. Golf on Friday because that practice round is early morning on Saturday. Consequently, we allow time for our TEAM to practice on the Championship venue on Friday because Official Registration and Check-In for States opens on that Friday. Both the Friday and Saturday practices are crucial to individual and team success. Unless somebody is a single digit handicap and has played the Robert Trent Jones GC at Cornell University, it may be extremely difficult for someone to understand the importance of these two practice rounds for the player and his team. The Championship Golf Course and playing Tournament Golf is completely different that playing golf on the weekends for recreation at 99% of the golf courses in Section VI. In regards to the golf course – in many cases there are (3) to (4) club differences depending on where they place the pins on the large, undulated greens and the course plays a lot different dry versus wet, wind versus no-wind.

As many of you are aware, I'm passionate about Boy's Golf and providing our boy's their very best opportunity to succeed at states both individually and as a team. Having our team on the course twice before Sunday is crucial and in my opinion well deserved.

There are approximately 570 school districts in NYS that participate in Boy's Golf – over 8,000 players. Our (9) boy's represent the top 1/10th of 1% of public HS golfers in all of NYS. Boy's Golf is unlike any other sport in NYSPHSAA – it is special, unique compared to other team sports and should in my opinion, be viewed and treated as such.

My recommendation would be for there to be a strong recommendation from Section VI to NYSPHSAA that they change the dates for Boy's Golf and Tennis if at all possible WITHOUT changing the venue sites.

Lastly, I recommend that a Section VI Policy be instituted to state that if a player is in both tennis and golf, he must choose a championship regardless if the player is eliminated in Tennis before the weekend due to the travel time between Flushing and Ithaca and the physical fatigue the player will experience after 2 to 4 days of practice and tournament tennis. At a minimum, the player who is in both Tennis and Golf for States should be required to attend both golf team practices (with full participation, all 36 holes with his team) or the alternate will be called up to replace them provided that the alternate is able to fully participate in the Saturday practice round. (We would know Friday afternoon if a boy in tennis qualified into Saturday)

As you can see, conflicting State Championships places everyone in a bad position. I'd like to see some clarification made to protect the team element of Boy's Golf (It's been a TEAM competition at STATES since 1973) and the ideally eliminate the conflict altogether with a date change or policy statement.
