#### Action Items Approved/ Major Discussion:

-Officials are asking high schools to use the NCAA pre match warm up protocol.

- Motion: To revert to NCAA pre match warm up protocol by Mary Jo Cerqua, Second by Dave Tytler Passed-unanimously
- Motion: To modify the Standard Operational Procedures to include the NCAA pre match warm up by Peggy Seese, Second by Sue McLean Passed-unanimously (to be taken to the Executive Committee May 2) Document is to be updated.
- Motion: For a blanket waiver (statewide) for the NCAA Volleyball requirement of court striping by Peggy Seese, Second by Dave Tytler Passed-unanimously

-Major discussion on rule set being voted on in May by Executive Committee. The Volleyball Committee is in support of staying with NCAA rules. Sally Wise stressed and presented the concern of the many Officials that would be lost with a change in rules (already a shortage of Officials). State Committee is also concerned about the amount of Officials as well as monetary issues for schools (officials' stands, volleyballs and uniforms-for example)

-Two Regional matchup proposals were presented by Steven Boucher. (matchups attached)

Motion: To present Proposal 1 for a two year cycle by Diane Swartfager, Second by Mary Jo Cerqua Passed -two opposed

If Proposal 1 doesn't get through, we will revert to the current format.

Peggy Seese makes the recommendation that we keep the Volleyball numbers through 2020 but revisit the numbers is November.
